- Key pillars of evaluation done by the tool are as follows:

- 1. Network / Application Profile- Development activity, number of nodes, foundation year etc.
- 2. Economic Factors- Financial standing and liquidity.
- 3. Environment Factors- Energy consumption and efficiency
- 4. Governance Factors- Stakeholder materiality, ethics, and regulatory compliance.
- 5. Technology Factors- Innovation, security, and technological performance
- 6. Strategy Implementation and Risk Management Factors- KPIs, monitoring and tracking. The questionnaire is an easy to answer form created on a smart platform. Questions are either quantitative or qualitative. For qualitative questions scoring is based on Likert's scale. The assessment methodology is defined in such a way that the scores can then be categorized into four levels:
